General Information:

Transferable limited entry permits survive the death of the permit holder. The permit may be transferred directly to the surviving spouse by right of survivorship unless the deceased holder expressed a contrary intent in a will which has been probated. If the permit is to be transferred to someone other than the surviving spouse, the authorized representative of the estate may make final disposition of the permit by providing a copy of letters of appointment or administration along with the transfer form.

There are permits in a few fisheries which CANNOT be permanently transferred because they were issued under the "minor economic hardship" provisions of the regulations. These nontransferable permits revert to the State upon the death of the holder (or when the holder stops paying renewal fees) and they are NOT reissued.

To receive the permit the surviving spouse does not have to be physically able to fish or intend to fish the permit.

Permits cannot be leased, pledged, mortgaged, attached, distrained, transferred with any retained right of repossession or foreclosure, or encumbered in any way, or on any condition requiring a subsequent transfer.

Information in regards to permit financing is available from the Department of Commerce, Community and Economic Development, Division of Economic Development, phone 907-465-2510 or Alaska Commercial Fishing and Agriculture Bank (CFAB), phone 907-276-2007. An entry permit cannot be permanently transferred while it is subject to a lien filed by the Division of Economic Development, the Commercial Fishing and Agriculture (CFAB), or Child Support Services Division (CSSD). Permits may be subject to federal tax liens and the Internal Revenue Service does not notify the Commission of such liens. The parties to a permit transfer are advised to take appropriate measures to protect themselves from the risks associated with federal tax liens.

Instructions:

This form must be completed by the surviving spouse and submitted to the Entry Commission along with a copy of the death certificate and the will if the deceased permit holder left one. If the permit has been renewed for the current year the permit card must be submitted with the transfer documents. The permit does not have to be renewed for the current year however, any prior years must be paid. You must submit a \$50.00 transfer processing fee along with the completed form.

At least 90 days must have lapsed from the date of death before the Entry Commission can permanently transfer the permit.
