General Information:

- Entry permits are transferable only through CFEC. Permanent transfer requests that do not comply with CFEC rules will be denied even if the parties have already signed legal documents and/or exchanged money. AS 16.43.170(a).
- The legislature designed the limited entry permit system to ensure commercial fishing privileges in Alaska benefit <u>individuals</u> who <u>actively participate</u> in the fishery. Consequently, the following rules apply to all permanent transfer requests:
 - CFEC regulation 20 AAC 05.1705(a): "Except as provided in AS 16.43.150(g), an entry permit may not be (1) pledged, mortgaged, leased, or encumbered in any way, including any contractual or legal device that purports to require the transfer or forfeiture of a permit or otherwise constrain the rights of the holder to possess or transfer an entry permit; (2) transferred with any retained right of repossession or foreclosure, or on any condition requiring subsequent transfer, even if set out as an alternative to another action; or (3) attached, distrained, or sold on execution of judgment or under any other process or order of any court, or otherwise involuntarily transferred except due to an execution on a holder's interest in a permit as provided in AS 16.43.170(g) and (h) and 20 AAC 05.1700 20 AAC 05.1770."
 - The total number of entry permits that may be held by a person in a specific fishery is restricted by law. It is unlawful to create a 'side' agreement in violation of 20 AAC 05.1705(a) to encumber or control additional permits through a proxy.
 - A proposed transferee must provide facts establishing the transferee's present ability to participate actively in the fishery to which the permit applies. 20 AAC 05.1707(a).
- A prospective purchaser of an entry permit who is a resident of this state may seek financial assistance from the Division of Economic Development (DED), 907-465-2510, or the Commercial Fishing and Agriculture Bank (CFAB), 907-276-2007.
- An entry permit cannot be permanently transferred while it is subject to a lien filed by DED, CFAB, Child Support Services, or the Internal Revenue Service (IRS).

Instructions:

- An applicant for a permanent transfer must first file a Notice of Intent form with CFEC; the Notice of Intent must be on file with CFEC for <u>60 days</u> before the permanent transfer request can be processed. Note: If the mandatory 60-day period cannot be satisfied prior to the upcoming fishing season, the transferor can request a temporary emergency transfer of the permit which would allow the proposed transferee to utilize the permit while the permanent transfer request is pending.
- The transferor and proposed transferee must submit a 'Request for Permanent Transfer of Entry Permit' form to CFEC along with a \$50.00 permanent transfer fee. If the proposed transferee already holds the same type of salmon permit -- except Cook Inlet set gillnet, Cook Inlet drift gillnet or Yakutat set gillnet -- the applicant must submit a "fleet consolidation" form instead.
- The signatures on the 'Request for Permanent Transfer of Entry Permit' form must be notarized, but the parties do not have to sign it at the same time or place. The form must be submitted to CFEC within 90 days of when it was signed. 20 AAC 05.1712(d).
- A copy of the "transfer agreement" or "bill of sale", which discloses the complete terms and conditions of the proposed transfer must be submitted along with the application. 20 AAC 05.1712(c).
- If the permit is to be "gifted" (i.e. transferred to the other party without a fair value exchange of compensation), a 'gift affidavit' must be completed to ensure that the parties understand the nature of the privilege being given away and the applicable rules. If the permit is a gift, please submit a completed 'gift affidavit' (see Attachment A, two pages) along with your application.
- If an embossed permit card has already been issued to the transferor for the current year, the transferor must return the card or provide CFEC with proof that the card has been destroyed.
- If the transferee will be fishing from a vessel that is not licensed for the current year, the transferee must submit a 'Vessel License Application' and pay the applicable fee before an embossed permit card can be issued. 20 AAC 05.560(e).
- **ESTATES**: If a permit is held by a deceased fisherman's estate, only the legally authorized representative of the estate may apply for a permanent transfer of the permit. A copy of the 'Letters of Administration' or 'Letters Testamentary' verifying the person's legal authority to act on behalf of the estate must be submitted with the transfer request.




