

ATTENTION

The following individuals held limited entry permits for commercial fishing which have been forfeited for a failure to pay renewal fees for two consecutive years (2017-2018), as required by AS 16.43.150(d). Notice of this action has been mailed to the former permit holder.

A permit forfeited under AS 16.43.150(d) may be reinstated by the commission upon a showing of good cause. Good cause may include the following: (1) administrative closure for the entire season of the specific fishery for which nonpayment of permit fees led to forfeiture of the permit; (2) temporary illness or disability; (3) death of the permit holder; (4) the loss of a vessel or equipment through sinking, destruction, or extensive mechanical breakdown; and (5) other objectively verifiable causes of inability to pay permit renewal fees that the commission determines to be good cause.

If you wish to explain your circumstances to the commission or you believe the forfeiture action was made in error, you have the right to request a hearing under 20 AAC 05.1805. The request for a hearing must be in writing and contain a statement of why the commission's determination should be changed, and indicate which findings of fact, interpretation of regulation, or interpretation of statute you believe to be in error. The hearing will be granted if your written request demonstrates that there is a genuine issue to be resolved.

The request for a hearing must be postmarked or delivered to the Commission on or before the forty-fifth (45) day that notice of the permit forfeiture was mailed out by the commission.
